LAKE METROPARKS AND NGLCO SPECIAL EVENT INDEMNIFICATION AGREEMENT

THIS SPECIAL EVENT INDEMNIFICATION is to provide indemnification to NURSERY GROWERS OF LAKE COUNTY OHIO, INC. (NGLCO) its successors and assigns (NGLCO) and Lake Metroparks, its Board of Park Commissioners for Lake Metroparks, officers, directors, agents, employees and volunteers, by the _____ (the vendor) on the date herein below written by the vendor executing this Agreement.

WHEREAS, NGLCO and Lake Metroparks are conducting a special event entitled The Nursery Growers of Lake County Ohio Field Day (the "Event"), which will feature various attractions, including but not limited to, displays related to the nursery industry and allied trades, equipment demonstrations, educational activities, informal dining, and general merchandise related to the Event:

The Vendor further agrees to waive, release, forbear from and hold harmless the NGLCO and Lake Metroparks and indemnify NGLCO and Lake Metroparks from and against any and all damages, costs or expenses, including all attorney's fees, and all suits, claims and actions, at law or in equity, that may arise as a result of or in the course of the Event from any act of God, nature or other events beyond the reasonable control of NGLCO and Lake Metroparks, its officers, directors, agents, employees and volunteers. This indemnity and waiver of liability shall survive the term or termination of this Agreement as to any claims arising before the expiration or termination of this Agreement.
